1. All Entries must be made using the special **HIGHLAND DANCE ENTRY FORM** and provided to the Entry Secretary with the fee and a **SELF ADDRESSED STAMPED ENVELOPE**. Dance number and entry pass for the competitor over the age of 6 will be mailed to competitors IF completed entry, fee and envelope are received by
2. No refunds are provided for the entries received. A \$35 fee will be charged for NSF cheques.
3. The competition will be governed by the rules and regulations of the **SOBHD and ScotDanceBC**.
4. Competitors must be registered with the **SOBHD** through an appropriate agent (i.e. **ScotDance Canada, FUTSA**). Awards will be withheld from any competitor who does not present a valid registration card at the competition.
5. The convenor reserves the right to alter the program or cancel an event. All competitors must dance using music and swords provided by the convenor.
6. Category age splits will be determined at the convenor's discretion, dependent on the number of entries received. Competitors must dance only in their respective age groups. Age of dancer is calculated using their age as at the date of the competition
7. Competitors will dance in inverse order of entry and will fill in for Reels as required. Dancers filling in for any reel must complete the entire dance.
8. Only marshals and competitors are permitted in the marshalling area. Any competitor not ready to dance in an event and waiting in the marshalling area at the appropriate time will forfeit their entry in that event.
9. Competitors must be suitably attired. All competitors must be in full costume to receive their medals or prizes.
10. Protests must be made in writing and given to the convenor at the event. All decisions of the competition organizer and judges are final, including the number of placements in an event.
11. **STEPS (FOR ALL CLASSES): Fling (4), Sword (2+1), Seann Triubhas (3+1), All Nationals and Hornpipe (4), Barracks Johnnie (4), and Jig.**
12. Convenor must be notified of any class changes by August 21, 2019 (vhdacompetitionsecretary@gmail.com).
13. **ALL BEGINNER, NOVICE AND INTERMEDIATE DANCERS NEED TO ARRIVE BY 9:00AM. FIRST EVENT WILL BE FLING.**
